**DOG LICENSING FEES ARE AS FOLLOWS:**

Dog Licenses for the current year are to be renewed by January 31<sup>st</sup>. A late charge will be assessed beginning **March 1<sup>st</sup>**.

Renewals before March 1<sup>st</sup> **AND** Newly Registered Dogs in the Township  
\$15.00 for Spayed/Neutered Dogs ----- \$18.00 for Non-Spayed/Non-Neutered Dogs

**Proof of spay/neuter & rabies vaccination is required for new registrations. Rabies vaccination MUST be good through November 1<sup>st</sup> of 2023 or a letter from your vet stating they will not give the vaccine early.**

**Beginning March 1<sup>st</sup> a LATE FEE of \$15 PER DOG WILL BE ASSESSED ON EACH LICENSE RENEWAL. DOES NOT INCLUDE NEW REGISTRATIONS.**

**Please make checks out to Mount Holly Township. Only cash or checks are accepted.**

Licenses may be obtained by dropping off your application, copy of rabies vaccine & payment in the drop box at the Township of Mount Holly Municipal Building located at 23 Washington Street, visiting the Clerk's Office or by mail & send to: Mount Holly Township, Dog Licenses, PO Box 411, Mount Holly, NJ 08060. **LICENSES WILL NOT BE PROCESSED UNTIL THE 3<sup>RD</sup> WEEK OF JANUARY.**

***In accordance with Mount Holly Township Ordinance No. 2004-2, no more than two dogs shall be sheltered, kept, allowed or permitted in any one dwelling unit. A fee of \$100.00 per additional dog over two shall be charged annually in addition to the annual license fee. Please do not include this fee with the licensing fee.***

**NEW JERSEY LAW** – In accordance with N.J.A.C. 8:23A 4.1, no Municipal Clerk or other official designated to license dogs shall grant any such license and official metal registration tag for any dog unless the owner provides evidence that the dog to be licensed and registered has been inoculated for at least ten of the 12 months of the licensing period. Dogs with a duration of immunity against rabies that expires prior to the tenth month of the licensing period shall be revaccinated prior to issuance of a license. Proof of rabies inoculation must be submitted with application.
